All baggage should be clearly labelled both inside and outside with your name, address and phone number.

For travel to/from the USA and US territories and Canada

First Class/Business Class 2 pieces, the sum of three dimensions must not exceed 158cm for each bag.

Economy Class 2 pieces, the combined total of two bags must not exceed 272cm with no one bag exceeding 158cm. The minimum weight for each piece is 32kg.

For all other international travel

First Class 40kg

Business Class 30kg

Economy Class 20kg

## DUTY FREE

NZ Inbound Duty Free Allowance

Duty Free shopping is now available at the airport on your return to New Zealand at very competitive prices.

You may bring in one item for each of the following categories: -

(a) Tobacco - 20 cigarettes or 250grms of tobacco or 50 cigars or a mixture of all three weighing not more than 250 gms.

(b) Beer or Wine - 4.5 litres of wine (approx 6 x 750ml bottles) or 4.5 litres of port or 4.5 litres of beer (approx 12 cans).

(c) Spirits, Liqueurs. Spirituous beverages - one bottle containing not more than 1125ml.

(d) You may also bring in other goods to the combined value of \$700.00 free of duty and exempt of GST.

Over Allowance

Provided you do not exceed the allowance in (a-d) Customs allow you to bring in a further two bottles of spirits, or one carton of cigarettes under their special "over allowance provision".

Please enquire at any duty free outlet for further details.

Please remember that with possible changes in regulations and interpretations, it is your responsibility to make sure your duty free allowance is within the legal limits.
